CONDITIONS OF ENTRY

IES: The Lighting Society, Luminaire Design Award 2018 (LuDA) entry, will be accepted subject to the following conditions:

Scope:

Each submission should be limited to a single luminaire. The piece must have been completed in the 2 years previous to the closing date. Entries must include all supporting documentation as noted in this document, with additional requirements per each category as noted in this section.

Each entry shall nominate one of the four categories into which it is to be entered:

- A Conceptual Design Luminaire
- B Working Model Luminaire
- C In Production Luminaire
- D Bespoke Luminaire (one-off production)

Category A - Conceptual Design luminaire is limited only by your imagination; the luminaire is at conceptual design stage (pre-physical prototyping). Your entry shall provide preliminary technical drawings and 3D renders to communicate the design concept and its production value of the luminaire

Categories B - Working Model luminaires are one-off or handmade concept models up to a preproduction prototype. Your entry shall provide technical drawings, 3D renders, either a 3D printed prototype or handmade prototype of the luminaire, to communicate the design concept and its production value.

Categories C – In Production luminaire includes first production samples and production line luminaires. Your entry shall provide a working sample of the luminaire. The luminaire is to be in full working order, complete with lamp and any necessary control gear. The items shall be suitably packed for transport but capable of being readily reassembled, complete with mounting if necessary for correct orientation.

The luminaire performance information shall include lamp and control gear. The designer may however, state that these items, and any mountings required for demonstration purposes, if mechanically separate and not part of the luminaire design, are to be excluded from the design for assessment.

Category D – Bespoke Luminaire includes one-off designs purpose built for any particular task. Your entry shall provide technical drawings, concept renders and photographs of the installed luminaire. An owner's consent category D form must be provided giving permission for a site visit of the judging panel to assess the luminaire. If the entrant is not responsible for the initial design concept of the luminaire, then a credit for this designer must be included.

Entrants:

The designer, owner or any other principal participant in the design of the luminaire, may submit an entry for these awards. The entrant need not be a member of IES: The Lighting Society.

Only one entry will be accepted for each luminaire. Where the design is the result of teamwork, all the principal members of the team should be acknowledged in the design documentation. No luminaire may be submitted that has previously been entered in the IES: The Lighting Society Luminaire Design Awards. Any person associated with an entry will be disqualified to act as a judge in any capacity.



Origin:

Luminaires <u>must be</u> designed within the geographical area of the chapter entered. Significant local initiative and involvement are essential, and the luminaire must be intended for, already marketed in or available in Australia or New Zealand. Category C - In Production <u>must be</u> manufactured or assembled within the geographical area of the chapter entered.

Judging:

For Category D only, a judge, or judges' representative authorised by the judges, or the Chapter Management Committee, will visit as required, the site of all entries. The purpose of the visit shall be to evaluate the light sculpture/installation and statements made by entrant(s). The judges cannot enter into correspondence or discussion with the entrants.

The panel of judges will decide and announce the results of judging and awards conferred. The decision of the Judges is final and no correspondence will be entered into. The judges reserve the right to not make any award.

Designer's Statement:

Within the entry form is a provision for the lighting designer to contribute a clear and succinct statement of the issues as noted under "Criteria". This statement must provide sufficient information to enable the judges to evaluate how the specific award criteria have been identified in the design, explain how any special problems have been solved and show that the intended results have been achieved. These statements have strict character restrictions, IES: The Lighting Society reserves the right to edit any statement provided if the character allocation has been exceeded.

Criteria:

To receive an award, the luminaire must achieve a high level of interest, aesthetic excellence, originality & technical execution. The judging of each submission is on merit. Entries will be judged on accustomedness with the criteria noted below.

The Criteria used for judging in all categories encompasses the following:

- Complexity or difficulty of the problem faced by the designer; uniqueness of concept
- Originality of design for the application
- Effectiveness of light control in achieving the design objective, choice of lamp and components selected
- Energy efficiency
- Cost effectiveness
- Simplicity of manufacture
- Marketability

Additional criteria for categories C and D:

- Quality of materials and finish
- Mechanical soundness of construction
- Ease of installation
- Ease of maintenance
- Use of available Australian and/or New Zealand sourced components
- Quality Assurance in manufacture
- Compliance with the appropriate Australian and/or New Zealand Standards



Awards:

The Luminaire Award is not a competition between the submitted entries. More than one award may be presented at each level.

There are two levels of award possible:

- Award of Excellence
- Award of Commendation

A framed certificate of the appropriate level will be awarded to the luminaire designer(s) &/or company on the entry form. Included in the certificate is an allowance for additional contributor credits associated with the entry, at a maximum of 160 characters (optional). Please include these in order of importance, extra credits over the 160 characters can only be acknowledged in the Lighting magazine. IES: The Lighting Society reserves the right to edit the information provided, to comply with the character restrictions on the award certificates.

Certificates are presented in a one framed format; the award of excellence also receives a trophy. Additional framed copies of award certificates can be obtained from IES: The Lighting Society at a cost of \$60.00, unframed certificates at \$25.00, and trophies at \$120.00 each including GST. Please select the relevant box(s) in this entry form, for a number of additional certificates and/or trophies. This cost will only be charged in the event that the entry is awarded and will be processed the day after the award function.

The announcement of the awardees and presentation of the certificates/trophies will be made on Friday 26th October 2018 at The Star Event Centre. **Entrants are to ensure that someone from their organisation is in attendance to accept the award.** All entries will be displayed at the presentation function and all awards will be featured in the official publication, website and social media of the IES: The Lighting Society.

Owners consent:

Categories A, B and C, owner's consent section must be included with the entry, if the entrant is not the owner of the luminaire.

Category D must provide the consent of the owner(s) or lessee of the premises by which the bespoke luminaire is located, and other interested parties must first be obtained before the entry is submitted. This is a requirement for judging, to access and possible later publication of Award recipient details.

Included in the owner's consent, is an optional area where the <u>owner</u> can provide a description of the brief given to the Luminaire/Lighting Designer, and to express their degree of satisfaction with the result. The owner(s) can submit this section directly to IES: The Lighting Society, via email to <u>mickreidy@optusnet.com.au</u>, if they choose to keep their comments confidential.

A signed consent form is the minimum requirement for an entry to be valid. It is the responsibility of the entrant to either include this section with their submission or confirm that the owner(s) has issued it to the IES: The Lighting Society.

Media consent:

The media consent form provided must be completed for the entry submission to be valid.



Images:

Up to <u>four</u> Photographs only, shall be supplied as jpeg files at a **minimum 600 DPI**, **1920x1080 pixels (landscape)** format; images <u>must not</u> include entry, company or photographer's name. Images supplied outside this format requirement will be edited &/or cropped for presentation purposes.

Photographs shall not contain any advertising content. All photographic material shall offer a true representation of the luminaire and shall not be enhanced or taken under supplementary lighting. Multiple photographs can be combined to fit the size requirements, e.g. three portrait photographs side by side to make one landscape image. All photograph(s) submitted must include a photography credit for the image(s) to be accepted, by completing the section provided in this entry form. These images are to be used at the discretion of IES: The Lighting Society in print media, website, social media and projection at the awards function.

Trade Names:

No trade names or trademarks shall be inappropriately displayed on any luminaire.

International LuDA:

All recipients of an SA award of Excellence are automatically entered into the International LiDA program. This is judged the following calendar year and awarded at a selected Chapter awards function of that year.

Indemnity:

Entrants shall hold the IES: The Lighting Society indemnified against any claims arising through loss of or damage to submissions. Entrants shall also hold the IES: The Lighting Society indemnified against any claims for breach of patents, copyright, trademarks and/ or licences that may arise through involvement in this competition.

Rejection:

The IES: The Lighting Society reserves the right to reject any non-conforming entry and refund the entry fee.

Entry fee:

The relevant category entry fee, must be included with the complete entry, compliant with the guidelines in this document. This must be received by the due date.



Entry deadline:

Deadline for submitting an entry is **Midnight AEST Friday 31**st **August 2018**. No entries will be accepted after this date. If electronic file sizes are greater than 10MB (including images) please forward all required documentation via an electronic file download link, such as dropbox or Hightail. Alternatively, send on an on USB or hard copy to the address in this document.

Note: presentation boards of the entry will be accepted by close of business the following day to the submission address noted in this document.
